Facility Standards and Notifications

Our clinic has submitted notifications to the Regional Bureau of Health and Welfare of the Ministry of Health, Labour and Welfare, confirming that we meet the following facility standards:

Information Sharing in Home Dental Care

With the consent of patients who are receiving home-based care and have difficulty visiting the clinic, we maintain a system for coordinated care that enables planned dental management using relevant medical and dental information.

Dental Outpatient Safety Measures I

Our clinic has designated dental professionals and medical safety managers who have completed training in medical safety. We are equipped with an Automated External Defibrillator (AED) and maintain a system to appropriately respond to emergencies and ensure safety during dental outpatient care.

Dental Outpatient Infection Control Measures I

We have appointed an infection control manager and established a comprehensive system to prevent hospital-acquired infections in our clinic.

Medical Coordination During Dental Treatment

When providing dental care, we are able to collaborate with the patient's primary care physician or hospital, enabling systemic monitoring and medical management during treatment.

Medical Coordination for Home Dental Care

We have established a system to manage the patient's general condition before, during, and after home dental treatment. In case of emergency, we collaborate with the following hospital to ensure a prompt response.

• Transcutaneous oxygen saturation monitor (Pulse oximeter)

· Oxygen (for artificial respiration and inhalation)

· Emergency resuscitation kit

emergency responses when necessary.

prevention of severe dental diseases (including oral function management), as well as

care tailored to the physical and mental characteristics of elderly and pediatric patients
